

MONTHLY CRIME REPORT (JUNE, 2023)



THE EXECUTIVE SUMMARY:

Half Year Summary, 2023:

In the first half of the year 2023, a total of **17265** crime related incidents have been reported to various law enforcement agencies within the sampled population. This is an increase compared to the total number of incidents that were reported in a similar period last year whereby a total of **15727** incidents were recorded. This represents a **9.78%** increase in crime rate during this period compared to the year 2022.

The most number of crime related incidents were recorded in the month of March in the first half of the year with a total **3090** incidents recorded. This represents a **15.53%** of the total number of incidents recorded during this period.

The safest month would be considered to have been January in the first half of the year where a total of **2452** incidents were recorded.

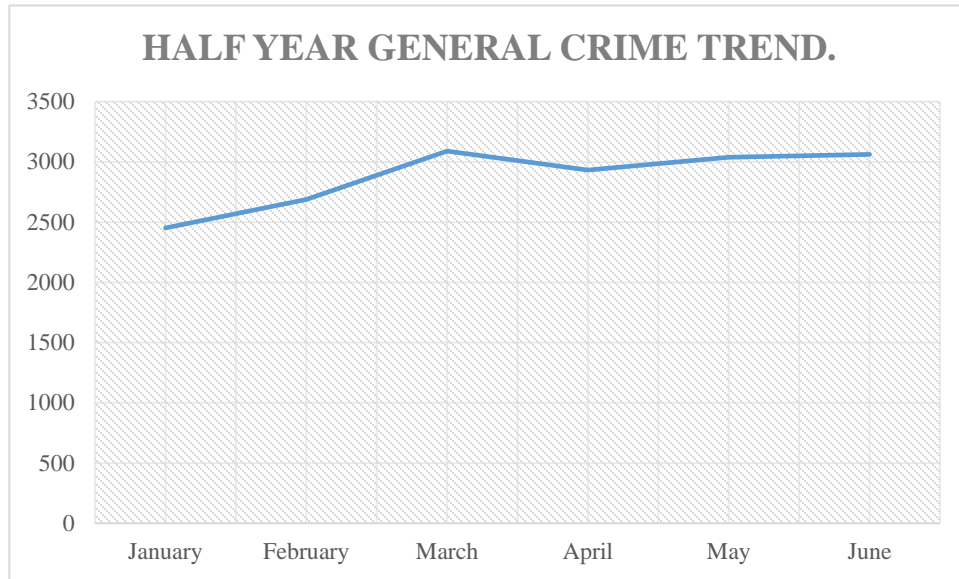
Under the four counties gazetted as cities within the Republic of Kenya, that is Nairobi, Kisumu, Mombasa and Nakuru, a total of **9113** crime related incidents have been reported in the first half of the year accounting for **52.78%** of the criminal activities witnessed in the sampled population in the similar period. **50.03%** of these incidents within the four cities in the first half of the year were recorded within Nairobi. The least number of incidents during this period were recorded in Kisumu with a total of **1074** cases being reported.

In the analysis done under crime per category for the cities, the most prevalent category of crime in the first half of the year was stealing followed by offences against persons with the statistics standing at **1860** cases and **1832** cases respectively. Cases surrounding homicide have been noted to have increased by **12.97%** in the first half year compared to the statistics for a similar period in the year 2022. A similar trend have been witnessed with cases relating to robbery with violence whereby a **15.63%** increase have been recorded in the first half of the year compared to the statistics for a similar period last year.

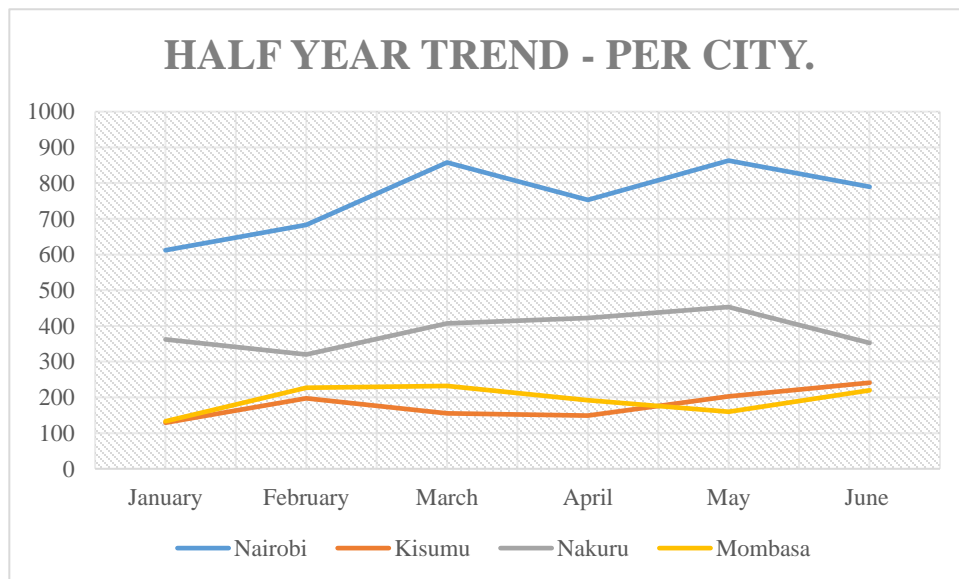
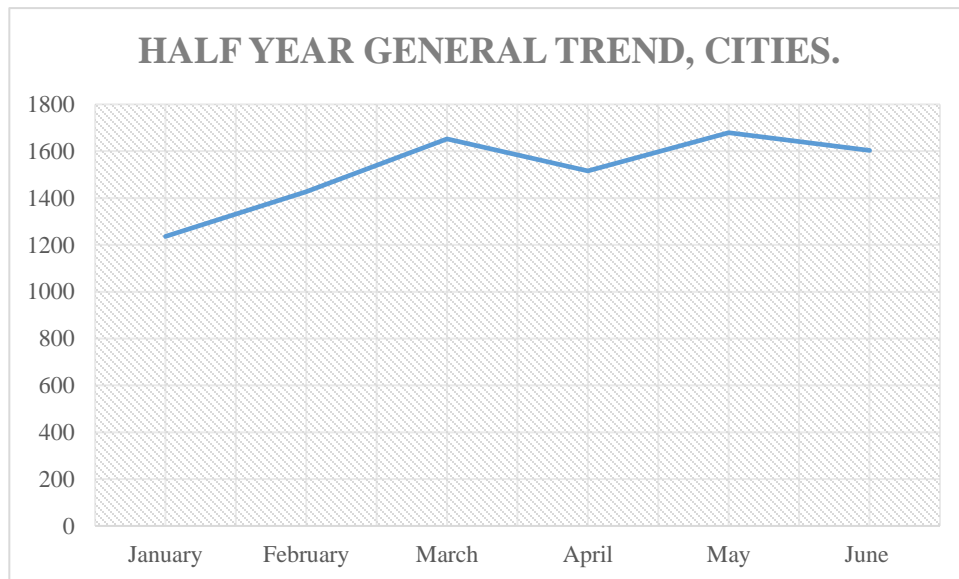
In the period under review, cases relating to economic crimes within the cities stood at **775** cases with a majority of them being obtaining money by false pretense. **68.39%** of the cases within the first half of the year were recorded within the Nairobi city.

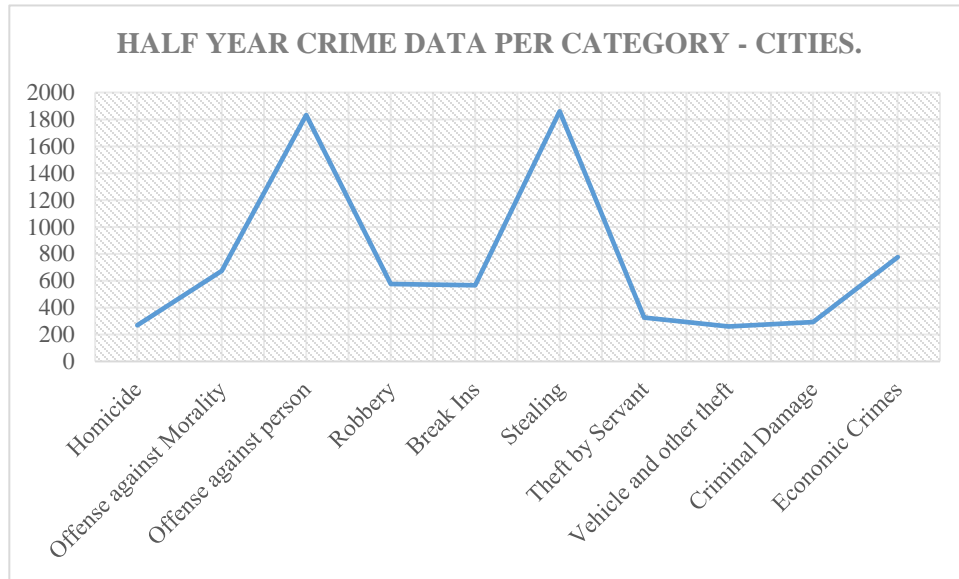
The Half Year Crime Trend – General, 2023.

Monthly Crime Summary – June, 2023:

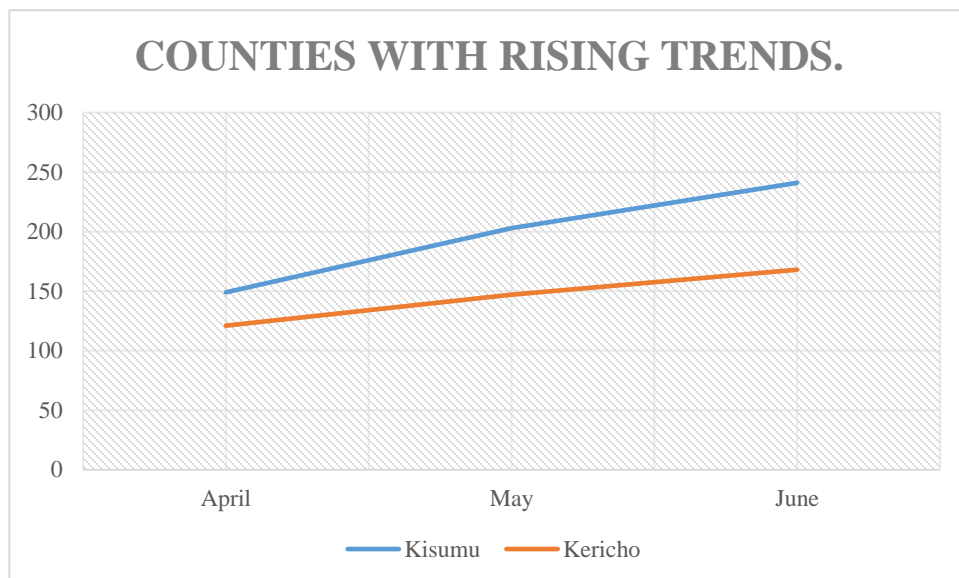
In June, 2023 a total of **3062** incidents were reported within the sampled counties with **25.80%** of these incidents being recorded within the Nairobi County.

This was closely followed by the Nakuru County where a total of **755** incidents were reported accounting for **24.66%** of the total number of incidents recorded in the same month.

A **0.76%** rise in crime was noted in the period under review compared to the May, 2023 statistics where a total of **3039** incidents were reported.

Over the past three months to June, 2023, Kisumu and Kericho counties have shown a steady rise in the crime trend.

Despite Kericho County recording an upward trend in terms of criminal activities in the last three months to June, 2023, the least number of incidents in the month under review was recorded in Kericho County with a total of **168** cases being recorded. This accounts for **5.49%** of the total number of incidents recorded in the period under review within the sampled counties.

On the other hand, there was a **4.53%** reduction in crime in the cities category. A total of **1603** cases were reported in June compared to **1679** cases that were reported in May, 2023.

Despite Kisumu having recorded an **18.72%** rise in crime rate over the period under review, the other county in the Western Region, Kakamega County, recorded a **15.86%** reduction in crime rate in the period under review.

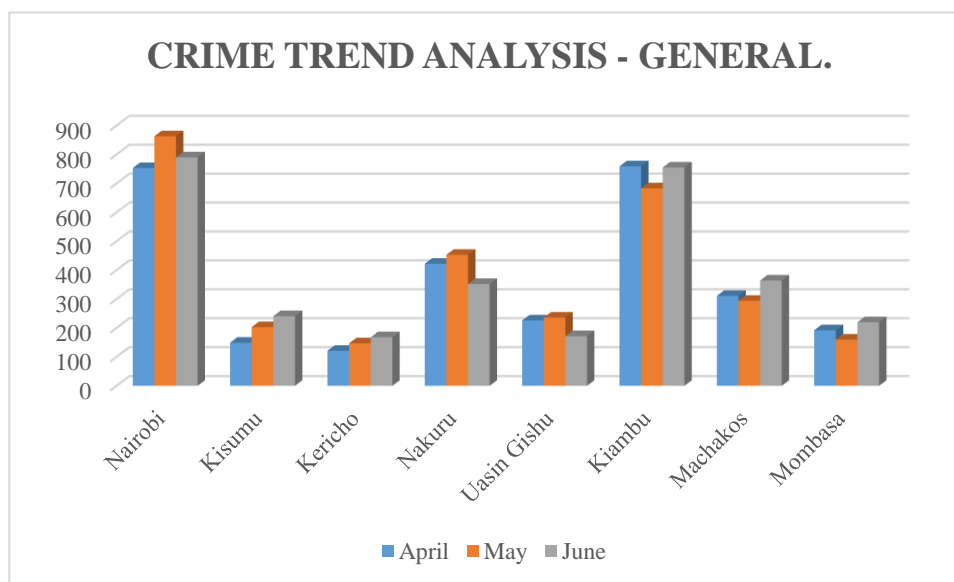
At the Coastal counties of Mombasa, Kilifi and Kwale, Mombasa County recorded a total of **220** cases in June compared to **160** cases that were recorded in May representing a **37.50%** rise in crime within Mombasa. Kwale County also recorded a rise in criminal activities in the period under review at **4.49%**.

On the other hand, Kilifi County recorded a **15.08%** reduction in crime rate in the period under review.

CRIME ANALYSIS PER CATEGORY – CITIES:

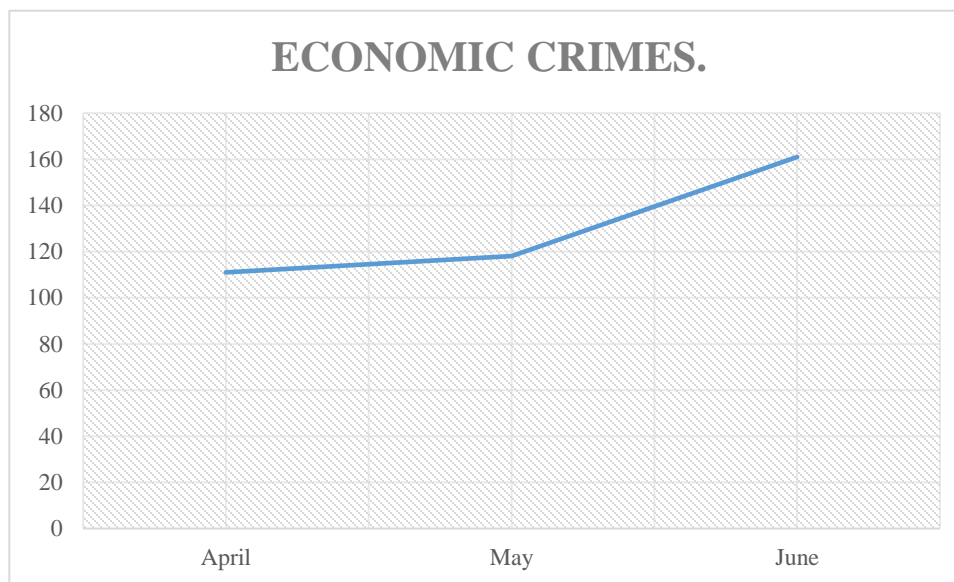
In the period under review, all the categories of crimes studied in this report witnessed a reduction in the number of cases reported apart from the crimes falling under the categories of offences against morality and those under economic crimes which recorded a percentage increase of **13.33%** and **36.44%** respectively.

In the past three months, crimes related to economic crimes have been noted to have taken an upward trend with a total of **161** cases being recorded in the month of June up from **118** cases that were recorded in the month of May, 2023.

Notably, **71.43%** of the cases reported under the economic crimes were registered under the Nairobi County with a total of **115** cases being reported to the various law enforcement agencies.

Under the different sub units of Economic crimes reported in the month of June, obtaining money by false pretense was noted to be the most prevalent accounting for **86.34%** of the cases reported under this category. This was followed by cases relating to fraud and forgery whereby only **20** cases were reported across the four cities.

Further under the economic crimes, only two cases of currency fraud were reported, that is one case in Kisumu County and the other in Mombasa County. No cases of false accounting were reported in the period under review in the cities.



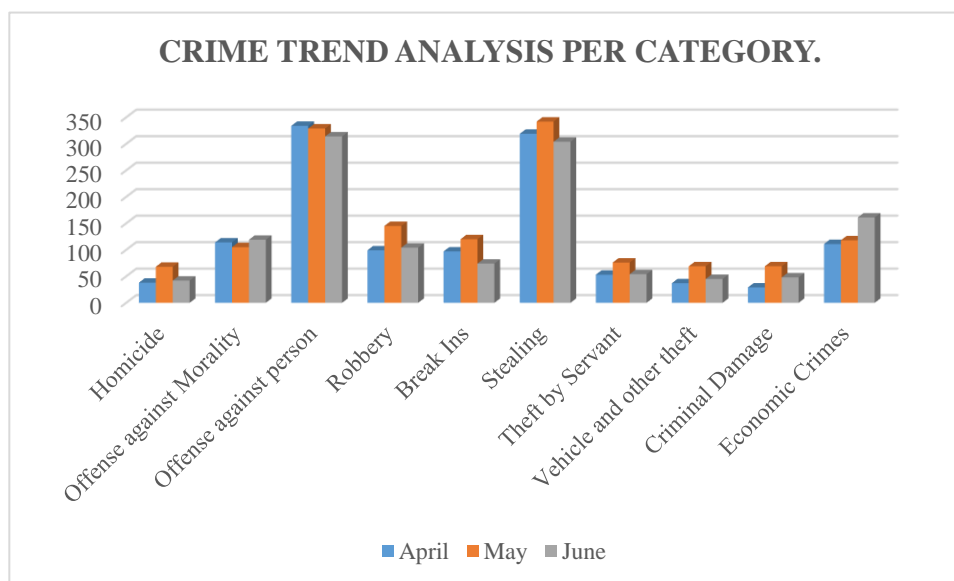
Even though a **34.78%** drop in incidents relating to the theft of motor vehicles and other thefts, this is an issue that is still raising a lot of concern given the modus operandi by the perpetrators of the crime. Out of the **45** cases that were reported in the month of June in the Cities, **33** of them were reported within the Nairobi county accounting for **73.33%** of the cases. **7** of the cases in the cities were those relating to the direct theft of motor vehicles while **24** cases were those relating to the direct theft of motor bikes. Theft from motor vehicles and theft of motor vehicle parts stood at **9** cases and **5** cases respectively. These figures could be more, the above

stated figures only relate to formal reports made to the police stations. Some victims opt to keep the matters to themselves mating under the imagination that nothing much will be done by the law enforcement agencies.

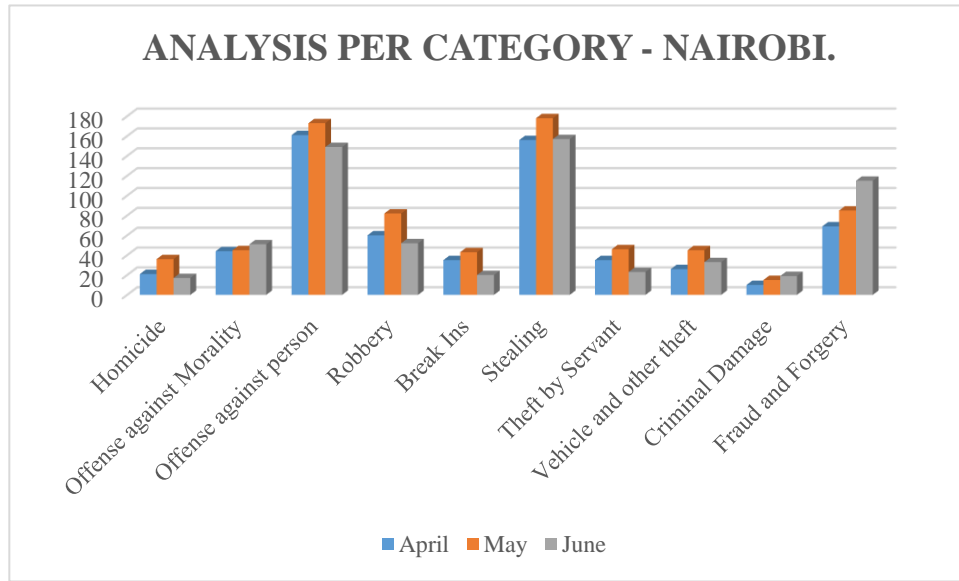
Graphical presentation of the crime per category: April to June, 2023:

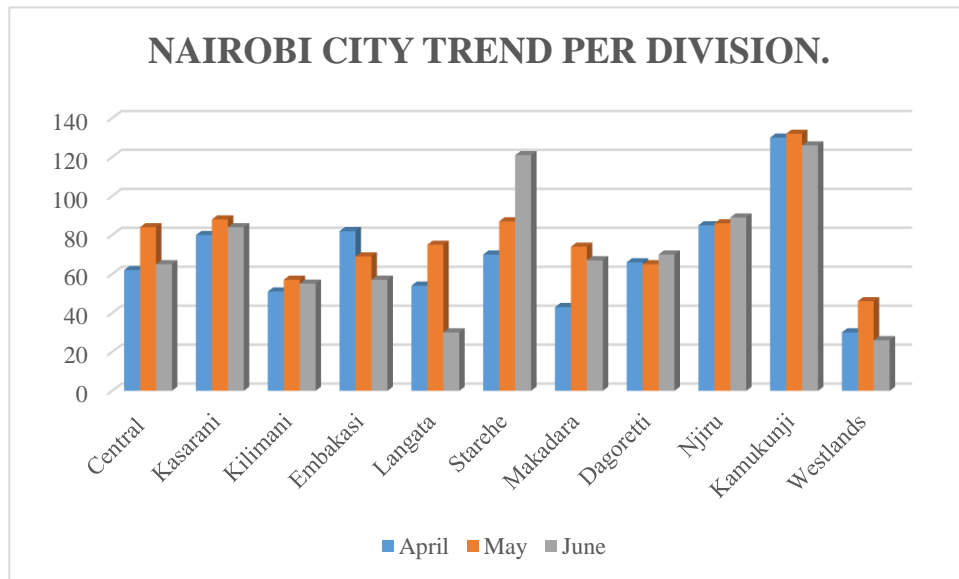
Graphical presentation of crime per category – Nairobi City (April to June, 2023):

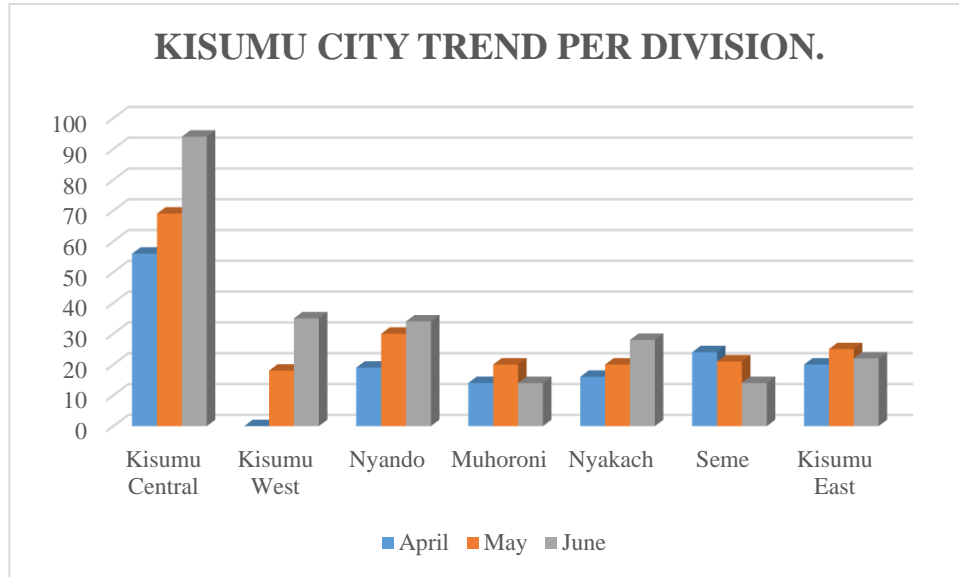
Nairobi City Analysis per Division:

Graphical presentation of Crime Data: April to June, 2023:



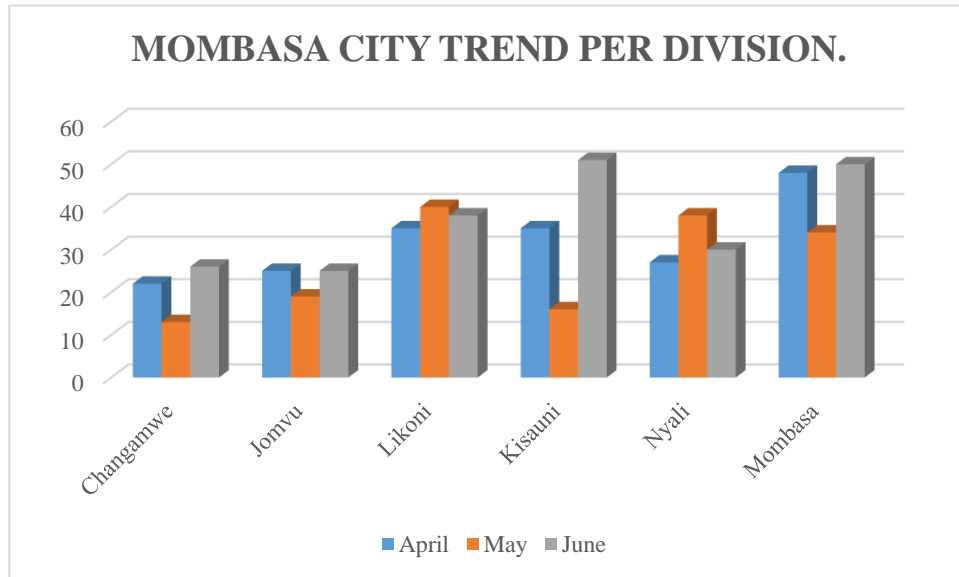
Kisumu City Analysis per Division:

Graphical Presentation of Crime Data: April to June, 2023:



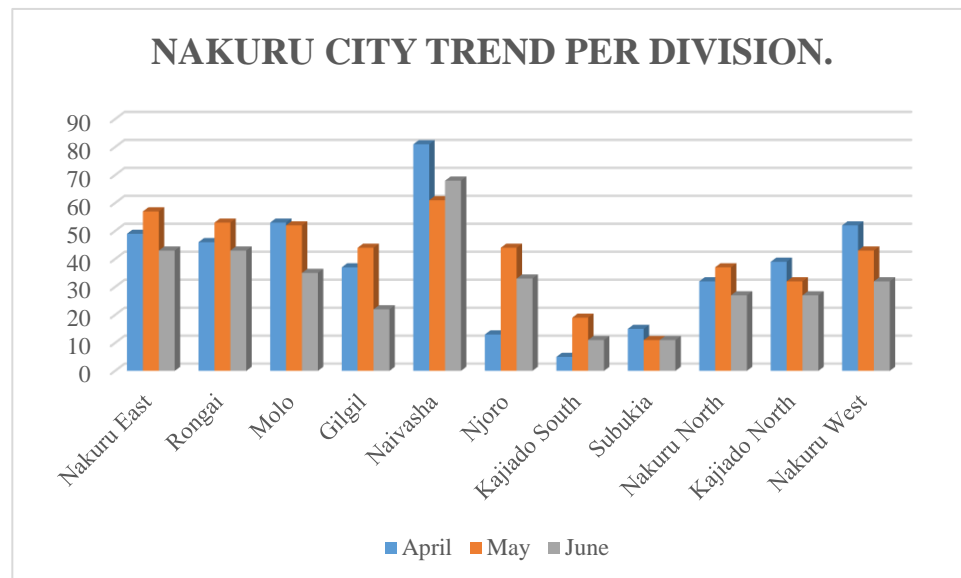
Mombasa City Analysis per Division:
