# RFSSL CRIME REPORT (APRIL, 2025.)







## **EXECUTIVE SUMMARY:**

# **Crime Analysis:**

In the crime statistics that has been analyzed from the sample population, a **1.70%** increase in crime rate was witnessed in the month of April, 2025 in comparison with the March, 2025 crime statistics. A total of **3,774** crime related incidents were reported in the month or April compared to **3,711** criminal incidents that were reported in the month of March.

In the period under review and within the sample population, crime was most prevalent in the Nairobi County where a total of **896** incidents were reported. This is a further **1.13%** increase in crime rate within the Nairobi County in comparison to the March, 2025 period where a total of **886** criminal activities were formally reported to the law enforcement agencies. In terms of crime prevalence within the period under review, the Nairobi County was closely followed by the Kiambu and the Nakuru Counties, which recorded a total of **660** and **384** incidents respectively. In all the counties that were sampled, all witnessed an increase in crime rate in the period of April, 2025 except for the Kisumu and Kilifi Counties which witnessed a **20.36%** and **14.94%** drop in crime rate.

The Machakos County witnessed the highest percentage increase in crime rate in the month of April at 30.19% and was followed by the Kwale County, which witnessed a 22.50% increase in crime rate.

It is worth noting that the counties of Nairobi, Kakamega, Kirinyaga and Kwale have in the past three months of February, March and April have steadily witnessed and increasing trend in crime rate.

Despite the general sample population recording a 1.70% increase in crime rate under the period under review, the counties gazetted as cities within the Republic



of Kenya, Nairobi, Kisumu, Mombasa and Nakuru recorded a **1.03%** decline in crime. A total of **1,722** criminal activities were recorded in the month of April in comparison to the **1,740** cases that were recorded in the month of March.

In the Nairobi County, crime was most prevalent in the Eastlands division of Buruburu where a total of **144** incidents were recorded. This is further a **58.24%** increase in crime rate within the Buruburu division in comparison to the March crime statistics whereby a total of **91** incidents were recorded. In the month of March within the Nairobi County, crime was most prevalent in Kayole division. Within the Nairobi County, the Kasarani, Kilimani, Starehe, Makadara, and Kayole divisions have in the past three months recorded a steady increase in crime rate.


Within the Kisumu County, crime was most prevalent in the Kisumu Central and Kisumu East divisions where a total of **48** and **39** incidents were reported. However, in the past three months, the Kisumu Central division have recorded a declining trend in criminal activities.

Within the Mombasa City, the most number of criminal activities were witnessed in the Changamwe division where a total of 63 incidents were reported. This is up from 48 incidents that were reported in the previous month of March representing a 31.25% increase in crime rate within the Changamwe division. The least number of incidents were recorded in the Mombasa Central division, where only 12 crime related incidents were recorded.


In Nakuru, the Nakuru East and Kajiado South divisions have recorded an increasing trend in crime rate of the past three months. Crime was most prevalent in Njoro division within the Nakuru County where a total of **66** incidents were recorded. This is a decline in crime rate within the same division in comparison to the March crime statistics where a total of **79** incidents were reported representing a **16.46%** decline in crime rate within the division.

#### **CRIME ANALYSIS PER CATEGORY:**

In the period under review, incidents falling under the category of theft by servant recorded the highest percentage increase at 33.33% whereby a total of 44 incidents were reported in the month of April in comparison to the 33 cases that were reported in the months of March as per the crime statistics for the cities.

Unlike in the month of March whereby incidents falling under the category of offenses against persons were the most common at 366 cases, in the period under review, the incidents falling under the category of stealing were the most common at 363 incident. This is further a 9.67% increase in the incidents falling under this category in comparison with the March crime statistics where a total of 331 stealing incidents were recorded.

The incidents falling under the category of offenses against morality recorded a major decline at 22.05% whereby a total of 99 incidents were recorded in the period under review in comparison to 127 cases that were recorded in the previous month. The same trend was witnessed with the homicide cases with recorded an 18.75% drop in the total number of cases witnessed under the period in review as per the




crime statistics for the cities. A total of **39** homicide cases were reported within the cities in the period April, 2025 in comparison to the **48** cases that were recorded in March.




On the other hand, incidents under the categories of stealing, break-ins and robbery with violence took an upward trend in the last three months to April, 2025.





Crime trend per Division – Nairobi:




Crime trend per Division – Kisumu:




