

CRIME REPORT (AUGUST 2025 ANALYSIS.)



EXECUTIVE SUMMARY:

Crime Analysis:

In the period under review, a total of **3,848** criminal cases were reported across the regions covered by this report. This is a **4.23%** increase in crime rate compared to the crime statistics for the month of July, 2025 whereby a total of **3,692** cases were reported.

Crime was most prevalent in Nairobi County where a total of **983** cases were recorded accounting for **25.55%** of the total number of cases that were recorded within the sample population in the period under review. Further to this, the Nairobi County witnessed a **17.44%** increase in crime rate in the month of August in comparison with the July crime statistics whereby a total of **837** criminal cases were reported.

Within the Nairobi County, crime was most prevalent in Kayole division where **155** criminal cases were recorded.

The Makadara division recorded the highest percentage increase in crime rate in the period under review at **227.78%** in comparison to July crime statistics.

Within the period of three months (June, July & August, 2025), in the county of Nairobi, the Central, Kilimani, Dagoretti, Ruai and Kayole divisions witnessed a steady and increasing crime rate. On the other hand, the Embakasi police division over the same period witnessed a decline in crime rate.

In the county of Kisumu, crime was most prevalent in the Central division where a total of **71** cases were recorded accounting for **26.39%** of the total number of cases that were recorded within the county. The Kisumu East and the Muhoroni divisions followed whereby **49** and **43** cases were recorded respectively.

In the past three months if June, July and August, 2025, Kisumu Central, Muhoroni and Kisumu East recorded and steady and increasing crime. On the other hand, the Nyando division witnessed a declining crime trend over the same period.

Nakuru County recorded a decline in crime rate in the period under review at **8.73%**. A total of **387** cases were reported in the period under review in comparison to **424** cases that were recorded in the previous review period.

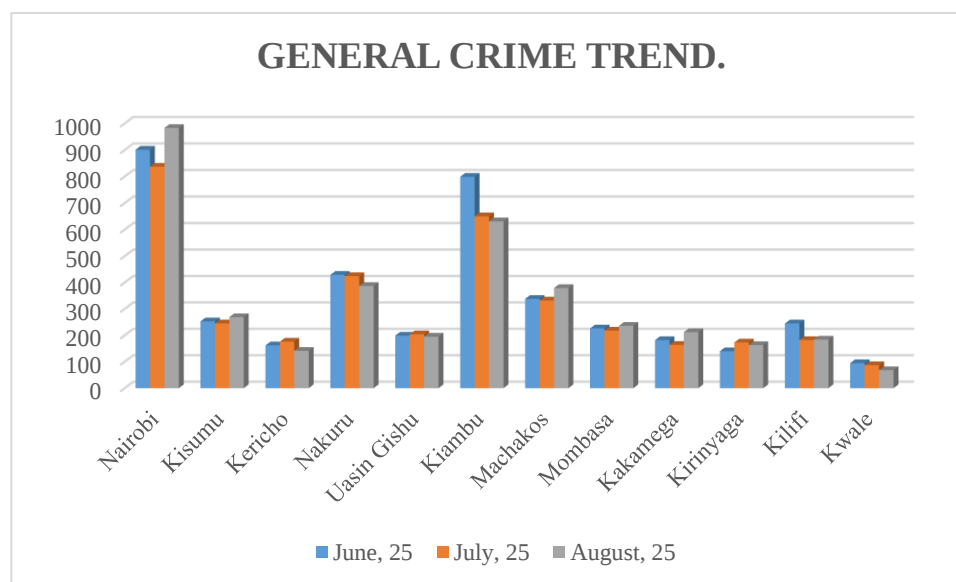
Mombasa County on the other hand recorded an increase in crime rate in the period under review at **8.26%**.

In summary, under the four-gazetted cities of Nairobi, Kisumu, Mombasa and Nakuru, there was an increase in crime by **151** cases representing an **8.76%** increase in crime rate in the period under review within the cities.

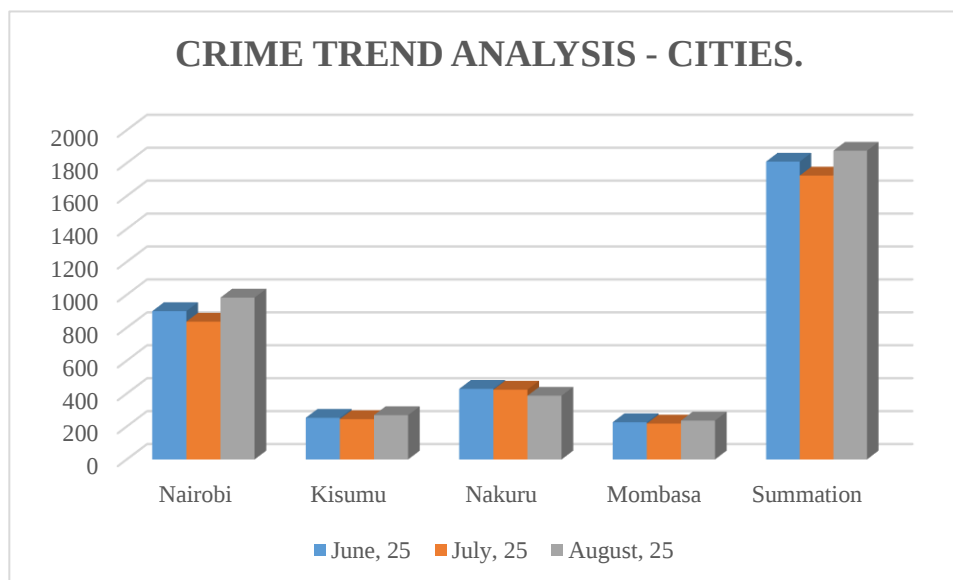
Graphical presentation: General Crime Trend to August, 2025:

CRIME ANALYSIS PER CATEGORY - CITIES:

There was a reduction by **27.27%** in relation to cases that were reported under the category of homicide. A total of **32** cases were recorded in the month under review in comparison to the July statistics whereby a total of **44** cases were reported. Most of the cases that were recorded under this category related to murder. Out of the **32** cases that were reported under the category of homicide, **21** were murder cases accounting for **65.63%** of the total number of cases that were reported under this category. Majority of the murder cases were reported in Nairobi and Nakuru. Both cities recorded **8** cases each while Kisumu and Mombasa recorded **4** cases and **1** case respectively.

In the period under review, there was a spike in robbery with violence cases. A total of **114** cases were recorded in the four cities of Nairobi, Kisumu, Mombasa and Nakuru. This is an increase from **89** cases that were recorded in the month of July representing a **28.09%** increase in the total number of cases that were recorded under this category. Out of the **114** cases that were recorded in the period under review, **73** cases were recorded in Nairobi alone; this further is a **40.38%** increase in cases of robbery with violence in Nairobi compared to the July crime statistics. Kisumu city recorded **13** cases of robbery with violence. This is a **6.21%** increase compared to the crime statistic for the previous review period. Nakuru and Mombasa recorded **15** and **18** cases respectively in the period under review.

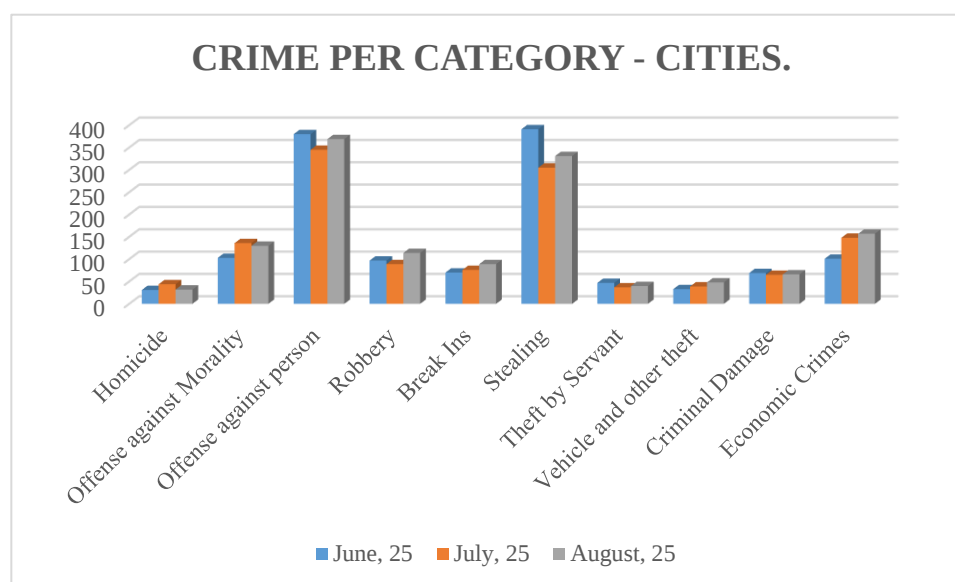
From the month of April, 2025 to the month of August, 2025, there has been a rising trend in the cases of theft of motor vehicles, theft of motor vehicle parts and theft from motor vehicles in Nairobi, Kisumu, Nakuru and

Mombasa. In the period under review, there was a **23.08%** rise in these cases. Nairobi city witnessed a very sharp rise by **62.50%** in the period under review.

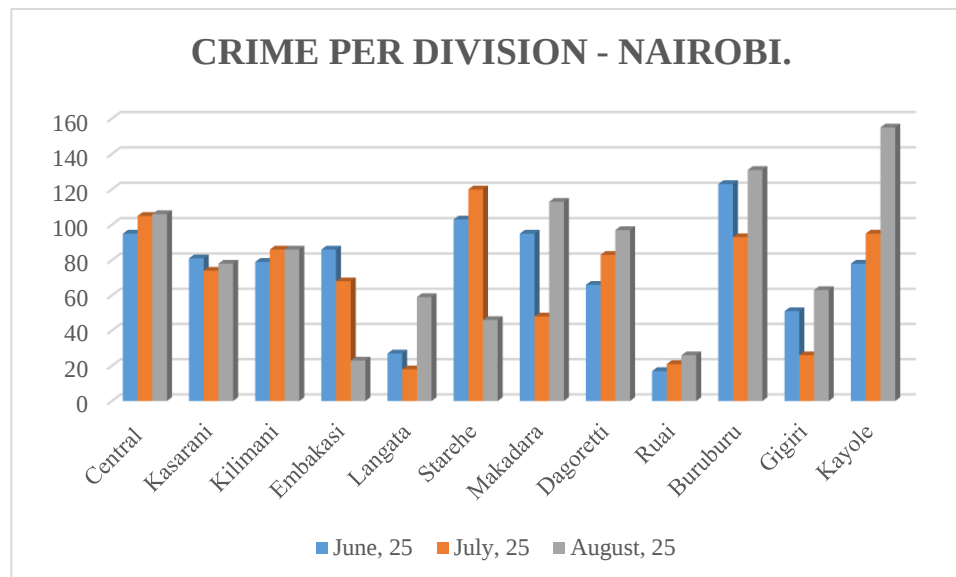

Graphical presentation of Data Crime per Category – Cities to August, 2025:

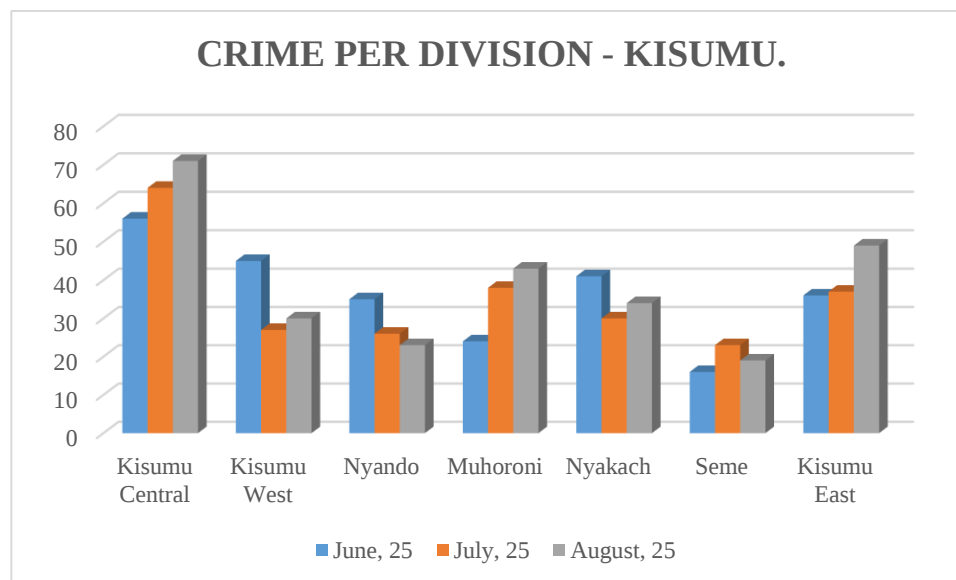

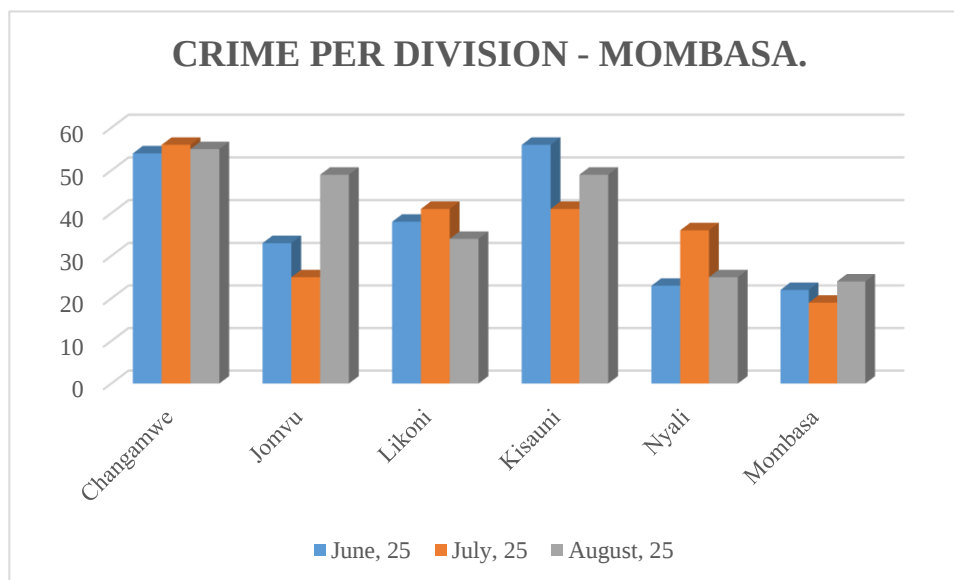
Crime Trend per Division: Nairobi City:



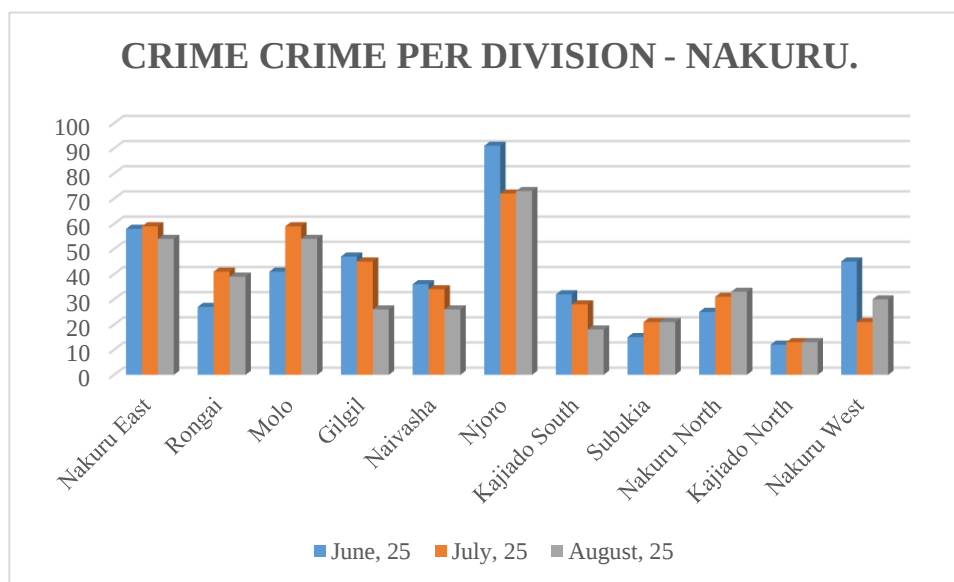
Crime Trend per Division: Kisumu City:
